# OTES Corner by Susan Withers

What's the difference between a Learning Walk and an OTES Walkthrough? Learning walks are generally unannounced short, targeted observations that any district administrator can complete. In a learning walk, the administrator is usually looking to collect data on the use of a specific teaching strategy/instructional technique that has been targeted in recent PD (for example: Explicit Instruction or Writing Revolution).

An OTES walkthrough may be unannounced and is completed by the teacher's evaluator. It must be at least 10 minutes in length and can be a short observation that is either general or specific in nature (re: area(s) of focus). It is important to note that walkthroughs resulting in identification of performance deficiencies or concerns shall be followed by a meeting within five (5) work days between the evaluator and the teacher in order to discuss questions arising from the observation.

**ETA Connects with Euclid HOPE Task Force by Kyle Simenc** The Euclid HOPE Task Force had their inaugural meeting on Tuesday, September 26th at the Church of the Epiphany located at 21000 Lakeshore. This task force was created to begin conversations between Euclid residents in order to reduce violence in the community. After introductions and a brief overview of the task force's goals, we broke out into groups where we focused on subjects such as school safety, community outreach opportunities, and how we can show support for Euclid in general. We hope to continue to grow this task force and our goal is to double our participation from 14 to 28 people at our next meeting at the Church of the Epiphany from 6-8PM on Tuesday, October 24th.
