OTES 2.0: What are the completion deadlines for the teacher evaluations? By, Darlene Puljic, ETA Secretary

At the start of every school year, all teachers must write their Professional Growth Plan (PGP). The deadline to meet with your administrator is September 30. Every teacher must have 2 goals that address an element of the Ohio Standards for the Teaching Profession. One of the goals must address the teacher's contributions to a building and/or district goal. Below are the timelines.

OTES 2.0 TIMELINE

- September 30 Deadline to complete Professional Growth Plan (PGP) •
- December 20 (End of First Semester) Deadline to Complete Round 1 of Formal **Observation Cycle**
- May 1 Deadline to Complete Round 2 of Formal Observation Cycle/Focused Observation and Evaluations of Off-Cycle Teachers
- May 10 Deadline for Final Holistic Rating

Your administrator will contact you to set up your goals.

CONTRACT LANGUAGE: 3.3 Professional Growth and Improvement Plans (Goal-Setting)

Annually the credentialed building Euclid administrators responsible for observation and evaluations shall meet with teachers to discuss and develop Professional Growth Plans or Improvement Plans set OTES goals.

Retirement Corner by Debbie Rudder, EHS, Retired ETA Teacher Retirement Incentives

1. If the School Board accepts your resignation before December 1st you will **NOT** be evaluated, but you may need to do goal setting in OTES. (Euclid wants these letters turned in during October for approval at the November School Board Meeting.)

2. Early Retirement Notification Payment-submit an irrevocable letter of resignation to the Superintendent's office no later than 4:00 p.m. on February 1 (no need to repeat your resignation letter). You will be paid .01 of the base(~\$450) in your last paycheck.

3. Early Retirement Incentive Plan-may be available when you plan to retire. It may require a certain number of teachers to participate. Be mindful of possible implications to your other incentives, such as severance.

4. Severance-compensation for unused sick time paid to **YOUR** district selected 403B account in January after retirement. Make sure you have an account with the **correct** company!
